FROM THE CHIEF'S DESK

LAND CLAIM

As everyone is aware, our Land Claim is before the court and will be continuing with hearings in Toronto. The hearings will be September 16,17,18,19,20,23,24,24, &30th. The court hearings will continue through the month of October and the plaintiffs will close the case Monday, November 18, 2019.

SON

The Saugeen Ojibway Nation is the collective community of both Saugeen and Nawash and the SON Environment office staff work for Joint Council.

Currently, information sessions are being held to inform the membership of the proposed DGR from OPG. I would encourage everyone to get informed about the project and vote in December. We need your vote, as OPG has committed not to build the DGR, if the communities are opposed. If the vote is NO to the DGR, we still need to have a conversation with OPG finding an alternative solution to the nuclear waste problem.

NEW BAND OFFICE

The new band office is currently being constructed behind the existing office. The new office will reflect the current multi-million dollar operation that Saugeen First Nation is. We will be moving at the speed of business, going into the future.

NEW BALL DIAMONDS

Currently, new plans have been drafted to construct two new ball diamonds beside the recreation centre. These two new ball diamonds will be state-of-the-art and will show case the new facilities for the start of the 2020 ball season.

SAUGEEN AWARENESS GROUP

This new group meets on Friday evenings and are attempting to deal with the ongoing growing substance abuse in the community. We are looking at a community meeting starting 2pm Sunday, October 6, 2019 at the recreation centre.

An Eye on Council with Sonya Roote

Greetings all, I hope everyone is enjoying the fall weather now that summer is gone, once again. I know it's been awhile since I reported in the Saugeen News. Sorry, it's been a very hectic time and the newsletter deadline seems to sneak up on me! Anyway, here's what I would like to pass along, from my own portfolios;

1. Our Infrastructure Committee has been working hard at trying to get as many new houses built/renovated as possible this year. We are building 2 homes in the main village. These homes will be turn key, once they are completed, we will have an open house and then everyone will be invited to apply for them. We have a house being moved from Port Elgin that we are going to place at Eagle Drive. The home is in great shape but we need to build a foundation for it and set up the septic system, etc. We also have a 4th house that the Band has repossessed and is now in the process of being renovated. Both of these homes will also have a call out for applications in the near future.

Also, our committee has gotten very creative about finding \$ to build tiny homes. We are going to have 6 tiny homes (single person dwellings) erected in the village, hopefully before the snow flies. We are also in the process of applying for a grant in the hopes that we can develop a tiny home subdivision.

I would just like to say that I am so very proud of our Infrastructure Committee team. Letitia Thompson is our Co-chair and Melissa Snowden, Diane John, Sabrina Misquadis and Paul Ritchie are our committee members. These people, along with our program Managers and resource people, have really done an awesome job this past year, trying to help put an end to our housing crisis. Way to go team!!

In total, we have 4 family homes being built/worked on for 4 of our families and 6 tiny homes that will be home to 6 more of our Band Members. Although it's not going to solve our housing crisis, it sure is a step in the right direction. Thank goodness for people who care and are committed to Saugeen. Milgwetch Infrastructure Committee!

2. As many are already aware, we were looking into to purchasing a property and the houses on it, in order to build our own family wellness center. This property is located close to the beach and in a perfect location for a place of healing. It would be un-intrusive to any neighbors and would be very private. Now, I think it may have been my fault for referring to it as a treatment center because people seem to have the wrong image in their mind about it. The actual idea is, to purchase the property and set up a family wellness center. The idea, in my head, is to have a place that our people can go, individually or with their families, to receive parenting and life skills, etc., a pre-treatment program and an aftercare program. The aftercare program would include the client's whole family. It would help families adjust and learn how to live a healthy life without drugs and alcohol. It would be staffed by caring professionals and, I feel, that it would greatly benefit our people as well as our whole community. The kicker is, is that it's very possible that we could get the purchase price fully refunded from Jordan's Principle, since it would include children's services.

Unfortunately, after getting a property assessment of the property and buildings, finding and protecting the \$'s to purchase it in Finance Committee and then bringing it through Infrastructure Committee as a recommendation to purchase, Council opposed it. To say I was disappointed, is a huge understatement. The thing that bothered me most, was that the property owner approached me and told me that, after Council opposed it, one of our Council members went to the owners and told them that Council opposed it because, "We can't put our addicts above our bread and butter". Honestly, the level of small mindedness and lack of empathy in that statement, just blew me away. In the midst of a drug crisis, with our young people dying from drugs, I would think that helping our people would be at the top of our priority list. I feel ashamed that one of our leaders think that our people with addictions fall lower on our list of priorities than cottagers do. As a matter of fact, there are already 2 cottagers that have volunteered to move their cottages if we needed more room and they are both Band Members. When approached with the idea. they were genuinely happy and said that it was an awesome idea and that it was about time we were looking into helping our own people. Also, before this shameful statement was made, I did explain to Council that this

center would be un-intrusive to any neighbors but, ultimately, it was opposed.

Just an FYI, our Social Committee will now be working on a plan to reintroduce the idea to Chief and Council in the near future. Don't worry, we will keep working on it until the wellness center becomes a reality. ©

3. As the Council Rep for working with CAS to establish our own child protection services, I am excited to say that we have put a call out for Band Members to sit on a working committee. This committee will be responsible for establishing and implementing our own guidelines, policies and protocols for child prevention and protection. This committee will be very busy and will need to work hard to meet our goals. The end result will be that Saugeen, rather than CAS, will be responsible for all of our children. It's so important that we get this right because we need to know that we have the tools, knowledge and capacity to keep all of our children safe and to ensure that they are not taken and placed with strangers outside of our community.

These are the updates that I have from the committees that I chair. Next month, I hope to include updates from other areas of Council. In the meantime, take care and be safe.

Let's do this Saugeen!!




FIRE SAFETY RULES


 Matches and lighters are NOT toys. Do not play with them. Give them to adults.

- 8. Learn how to use a fire extinguisher.




