This communique is to inform that our appeal in the Treaty and Title litigation (Treaty 72) has begun and it is scheduled for Monday May 8- Thursday May 11, 2023 and Monday May 15- Thursday May 18, 2023. The location is at Osgoode Hall, Toronto, 130 queen street west, court room 1.

The Chiefs from Saugeen and Neyaashiingmiing have both been present the first two days of the court hearings, with the flags (eagle staffs), along with a few leaders from both communities.

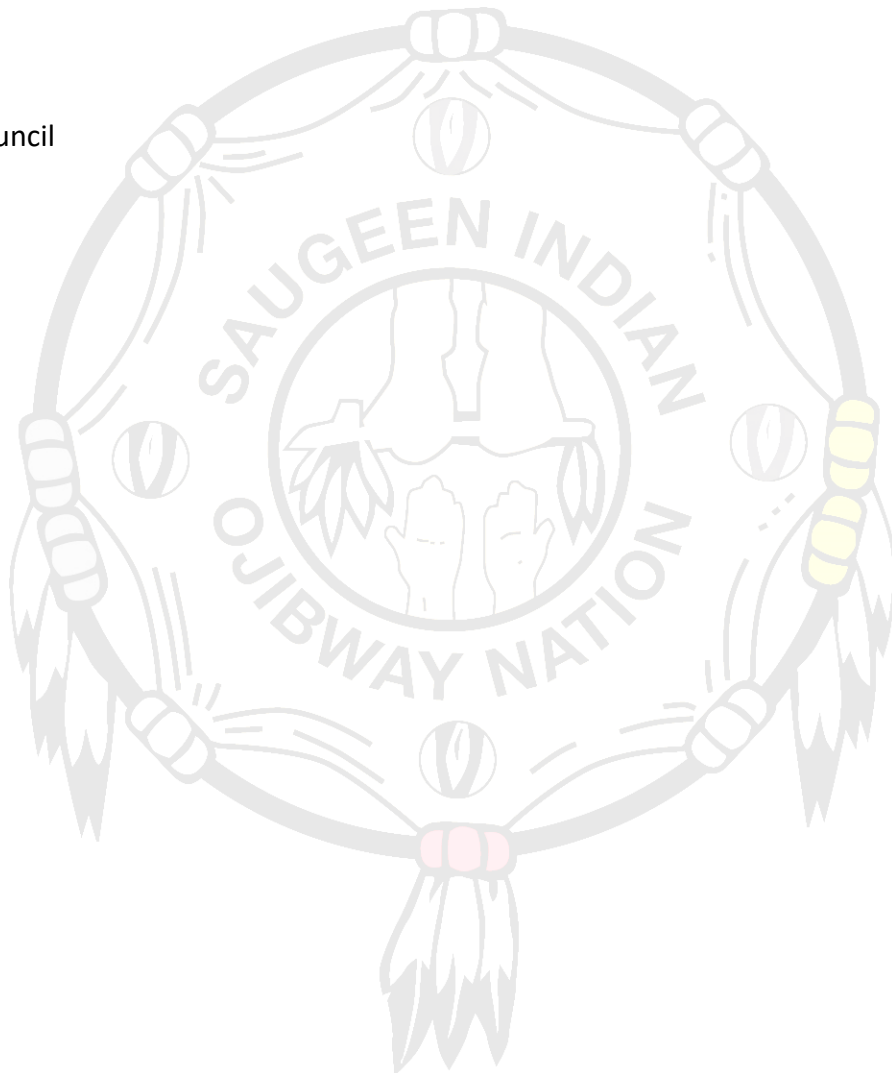
